The Nation's TOPLE Retail Credit Card Lenders

On the next several pages I've included profiles of the top 15 retail card lenders on the market. This is the most detailed and comprehensive resource ever compiled for consumers about retail cards.

And this isn't just the normal information you can find on the internet...I decided to provide details on cards that I've never seen published before. I set out to create a detailed account of the best card lenders in the country and extract the details important to you, which were either not mentioned in their marketing materials, or hidden in the fine print.

It is very important that you use these profiles as a guide, so you know what to look for in a retail store credit card. Because the risk of wasting an inquiry is so high, you must call and interview the lenders for yourself before you apply for any of these cards. Remember, "Trust, but verify."

WARNING! Retail card lending has evolved into one of the most volatile lending industries. The large, third party issuers jump in and out of the market with regularity. For example, while this report was being written, Capital One (who had recently purchased all of HSBC's retail card business) was in the process of selling off many of the cards they had just acquired. In addition, Citibank recently reversed course and decided to cancel the sale of several of their cards and re-enter the market segment. The profiles detailed in the next pages are accurate as of the printing of this report, but could change at any time.
